**ROADS LAW (2005 REVISION)  
SECTION 3 DECLARATION OF INTENT  
SECTION 6 AUTHORITY TO ENTER LANDS**

In exercise of the powers conferred on Cabinet by Sections 3 and 6 of the Roads Law (2005 Revision), and acting upon recommendation by the National Roads Authority, it is hereby declared that;

It is the intention of the National Roads Authority and in the public interest to open an access road as described hereunder:

<b>REGISTRATION SECTION:</b>	Lower Valley
<b>REGISTRATION BLOCK:</b>	32D
<b>BOUNDARY PLAN:</b>	BP 603
<b>PORTIONS OF LAND NEEDED:</b>	The proposed roadwork is defined by boundaries outlined in green on BP 603 and listed in the Schedule below.

The National Roads Authority is authorized to enter upon lands listed in the Schedule below for the purposes of undertaking any road works, such authority to take effect 15 days from the date of publication of this Notice in the Cayman Islands Gazette.

SECTION 5 DECLARATION OF PUBLIC ROAD**

In exercise of the powers conferred on Cabinet by Section 5 of the Roads Law (2005 Revision) on the recommendation of the National Roads Authority the following road is hereby classified as a public road and added to the schedule of public roads:
