SECTION 3 DECLARATION OF INTENT**

In exercise of the powers conferred on the Governor in Cabinet by Section 3 of the Roads Law (2005 Revision), acting upon recommendation by the National Roads Authority, it is hereby declared that it is the intention of the National Roads Authority to open an access road as described hereunder:

**REGISTRATION SECTION: WEST BAY BEACH SOUTH**  
**REGISTRATION BLOCK: 12C, 12E**  
**BOUNDARY PLAN: BP 536**  
**NATURE OF ROAD WORKS: TO CONSTRUCT HIGHWAY AS DEPICTED IN GREEN ON BP 536**
