ROADS LAW (2005 REVISION) Section 5 Declaration

In exercise of the powers conferred on the Governor in Cabinet by Sections 5 of the Roads Law (2005 Revision) the following road is hereby classified as a public road and added to the schedule of public roads:

REGISTRATION SECTION: West Bay Beach North
REGISTRATION BLOCK: 11B, 11C, 11D

DESCRIPTION: The public road is defined by boundaries edged in green on Prescribed Composite Map Number 285, which may be inspected at the offices of the National Roads Authority, North Sound Road, George Town, Grand Cayman and at Lands & Survey Dept, 133 Elgin Avenue, George Town, Grand Cayman.
